Dhanishta Foundation Annual Report 2021-22

Dhanishta expended Rs.1.28 Crores during the financial year 2021-22 for various charitable activities with the funds flowing in from patrons, charity lovers and other like-minded people. Briefly the charitable activities are enumerated here under

Food Distribution -

Food distribution to the poor and the needy is the first priority for Dhanishta. Dhanishta responds to the need and poor wherever it is noticed or brought to attention.

Food is distributed on a daily basis to the poor who clobber around temples and churches. Food is also distributed in differently abled children schools, and in institutions where Vedic education is imparted.

During the year Dhanishta Foundation has expended Rs. 10,19,691/- for the food distribution.

<u> Andari Talli Annadanam Project –</u>

With the inspiration given by our beloved Master K Parvathi Kumar, the Alumni of Rao & Kumar Chartered Accountants, conceived this Andari Talli Annadanam Project in the name of our beloved Founder Chairman Smt K Krishna Kumari, a novel project for distributing food on large scale to the needy on daily basis.

There has been a good response and huge appreciation for this project across the society. Since its inception Dhanishta has been distributing free

food on daily basis to 200 to 250 people on the foot paths that eagerly wait to receive from our relentless, dedicated and devout volunteers of this project. The food is being prepared with as much devotion as the foundation has towards Mother Krishna Kumari garu. During the year Dhanishta has expended Rs. 16,53,527/- for food distribution under this project.

Educational Assistance -

Educational needs of the poor and meritorious are attended to at Anantapur, Rajahmundry, Srikakulam, Vizianagaram, Bengaluru, Mysuru and Visakhapatnam. Assistance is given on the basis of merit and also the participation in the extracurricular activities. The students that receive help range from elementary education to post graduation.

During the year Dhanishta Foundation expended Rs. 9,55,047/- towards this cause. Details of assistance provided are as under:

- ➤ 4 students pursuing education from Nursery to Class 5 in AU English Medium School, Sri Bhavana School, in Visakhapatnam were given scholarships.
- ➤ 8 students from class 6th to 10th studying in SFS School, Kotak Selesian School, Sri Bhavana School and AU English Medium School in Visakhapatnam were given assistance.
- ➤ 2 Students studying Intermediate in Sri Chaitanya and Aditya College were given scholorships.
- ➤ 8 students pursuing their graduation in Nursing, Sciences and Commerce from various colleges in and around Visakhapatnam were given assistance for their education.
- ➤ 4 Students pursuing their Engineering from Raghu Engineering College, Lendi Institute of Engineering and Technology and Vignan's Institute of Engineering for Women were given assistance.

- ➤ 9 students from class 8th to 10th studying in Netaji Subhash Chandra Bose Municipal High School, Anantapuram were awarded with the shields and prize money under the able guidance of Sri R P Joshi garu and Sri V V Rama Krishna Sastry garu.
- ➤ 9 students from class 8th to 10th studying in Sri Potti Sri Ramulu Municipal High School, Anantapuram, were given shields of excellence and prize money for their performance.
- ➤ Based on the economic impact due to COVID-19, 19 students of Pragna Bharati School were given school uniforms.
- ➤ 9 students who showed their excellence in the academics were awarded with shields and prize money studying 8th to 10th class in Gramantara Kannada Medium High School, Chandapura and also around 510 students of the school were provided with notebook for the year 2021-22.
- ➤ 9 students studying 8th to 10th standards from Bheemanabeedu Government High school were given shield of excellence and prize money.
- ➤ Students who showed academic excellence studying PUC 10th and PUC in Sri Chinmaya Grameena Vidyalaya, Kolar, were awarded with shields and prizes.
- ➤ 4 students including a differently abled child studying in various colleges and schools were given the assistance who were around Bengaluru.

Other than the financial assistance Motivational talks were given not only to the students but also to the teaching staff at various school like Sri Vivekananda First Grade Rural College, Chandapura; Government High School, Hosahundi; Government High School, Hadinaru Village by Sri R P Joshi garu.

This apart, Dhanishta has adopted at Campus Challenge two blocks wherein 50 children that are differently abled and orphans. Campus Challenge is a residential school that provides academic education, vocational training and medical facilities to orphans, differently abled and physically challenged children at Poosapaturega, Visakahapatnam. In veneration to the relentless and tireless service rendered one block has been dedicated to Ammagaru Smt. Krishna Kumari garu and another block has been dedicated to Smt & Sri N V S Murthy garu. During this year Dhanishta has expended Rs. 6,97,500/for this project.

Marripudi Village Project -

Marripudi is a village in proximity to Bapatla. In this village there is a temple of Lord Siva which was constructed by the ancestors of our Mentor K Parvathi Kumar. At this temple free food distribution is done to the senior citizens of the village on every Monday and Thursday.

A free poly clinic is maintained for the benefit of villagers of 5 villages around Marripudi. Villagers come and receive the medical aid in terms of Allopathy, Homeopathy and Ayurveda on regular basis. A qualified RMP doctor and a compounder are always available in this clinic.

A small Gosala is maintained by the Temple members for which Dhanishta supports by providing cow fodder to the cows.

During the year Rs. 2,46,000/- was expended by Dhanishta Foundation for this project.

Assistance to senior citizens –

Old-age homes at Visakhapatnam and Ponnur are regularly assisted to provide food and other facilities to the poor and the destitute on a regular basis.

This year Dhanishta Foundation has expended Rs. 4,86,112/- for this cause.

Animal Care & Protection –

Dhanishta Foundation runs a Gosala, "Kamadhenu Cow Centre" at Chinna Tekkali Village with the help and cooperation of Sri U Ch B Varma, a philanthropist of the village. 50 cows and calves are given shelter, fodder and are taken good care at this center.

Further Dhanishta supports Kamadhenu Go-samrakshana Kendram, Rajahmundry where 135 cows are taken care by the members of the World Teach Trust, by providing necessary cow fodder and grass on a monthly basis.

During the year for the Protection of the Animal Kingdom Dhanishta Foundation has expended Rs. 12,90,279/-.

Computer education to the blind -

Dhanishta collaborates with the Alumni of Rao and Kumar chartered accountants and annually provides scholarships to the blind that learn skills for computer operation. In this regard, Dhanishta coordinates with Vision Aid a reputed organization at national level.

Dhanishta has utilized Rs. 1,25,000/- for the cause.

Wisdom Teaching and Training –

Dhanishta organizes regular meditation sessions, as also sessions to train in ritualism. It operates a temple, which is know as Wisdom Teaching Temple for teaching ancient wisdom; wisdom which is universal in its nature and effective for practical work.

Rs. 2,95,987/- was expended for the Wisdom Teaching Temple by Dhanishta Foundation during this year.

Self-transformation program -

Sreem and Raam are the cosmic seed sounds which are given by our seers relating to splendor and righteousness. Books are printed and distributed for writing the sound Sri Ram at the rate of 100 a day. This program is a self-sustained one. Dhanishta Foundation remains a facilitator. The books which are written are preserved in various parts of the country. This sacred work is done in the loving memory of late Sri K Venkatappayya Sastry garu, who is a great devotee of the mantra Sri Ram and also beloved father of our mentor Sri K Parvathi Kumar garu.

During the year Rs. 2,62,180/- was expended for the sacred cause.

Medical Assistance -

Dhanishta assists financially weak people who have medical needs. The Foundation facilitates treating the poor by way of free distribution of medicines and also by way of providing transportation to the physicians to reach the needy.

Dhanishta expended Rs. 3,98,612/- for the cause.

Financial Assistance -

Financial support is given to those who find it very difficult to meet both end in their lives. Dhanishta helps them by supporting financially for construction of their houses, for conducting the sacraments like marriages etc.

Dhanishta expended Rs. 2,15,000/- for this cause.

COVID Relief –

During the second wave of the pandemic Dhanishta has taken up a task of providing Oxygen Concentrators at free of cost for the use by the COVID effected persons.

Dhanishta has also procured and distributed Oxi Flow meters, NRBM Masks, N95 Masks, Face shields, Eye protection gear, Disposable gloves as part of COVID Relief activity to 3 government hospitals namely, at Visakhapatnam and one private hospital; St Joseph's hospital that runs on charitable basis.

Dhanishta expended Rs. 46,26,234/- for this cause.

Dhanishta has able coordinators to fulfill these activities. However Dhanishta also has part time staff to whom Salaries/Allowances are paid.

This year Staff Salaries/allowances expense at Dhanishta is to the tune of Rs. 6,72,400/-.

Dhanishta Publication:

The Wisdom teachings coming from Master K Parvathi Kumar are printed on public demand and are distributed at a subsidized cost. The wisdom coming through the Master is universal and is globally accepted. It is printed in Indian and also European languages. Dhanishta is the custodian of the teaching works of Master KPK.

This year Dhanishta Foundation has expended around Rs.10,94,158/towards the publication of the books coming from the pen of Master KPK. Details of books printed during the year are as under:
